# North Carolina Democratic Party Welcomes Vice President Harris to North Carolina

# ICYMI: Editorial: Lt. Gov. Robinson Needs to Answer Questions of Campaign Finance Irregularities

"Mark Robinson, now a candidate for governor, owes it to the state's voters to clear up these very serious concerns and questions. It would be one thing if these issues were an exception. But for Robinson, financial irregularities seem to be too much the norm in his campaigns and even his life."

According to a new WRAL Op-Ed, Mark Robinson has been "through three bankruptcies (1998, 1999 and 2003) and, according to court records, seven years of unpaid federal income taxes. He's even faced eviction from his home, after he failed to make payments."

From a review of Robinson's 2020 campaign finance reports, Robinson's campaign may, among several concerns listed, have:

- Used campaign cash to pay off personal loans;
- Improperly Accepted anonymous donations in excess of the allowable limits
- Accepted contributions from forbidden business sources;
- Accepted individual contributions in excess of the allowable limits;

- Accepted donations from out-of-state political action committees not authorized to be involved in North Carolina elections;
- Failed to disclose required donor identification information;
- Included discrepancies between total income from detailed contribution listing pages and that listed on the summary page.

"Mark Robinson can't even keep his own house in order and now he expects North Carolinians to entrust him as our state's CEO," said NCDP Chair Anderson Clayton. "This paper trail of mishandlings and financial irregularities gives voters across North Carolina yet another example of how dangerous his Governorship would be. We cannot afford to have Mark Robinson anywhere near the Governor's office."

**News from Neighbors on Call** 

NC Policy Update, January 8, 2023

#### Governance

- The top stories of 2023 at the North Carolina legislature: The GOP enacts new voting laws and abortion restrictions and agrees to Medicaid expansion -- Lynn Bonner, NC Newsline
- A series of laws went into effect on January 1. These included a set of changes to elections law (see more below in Voting Rights), an increase in registration fees for electric vehicles, regulations governing advertising for substance use disorder treatment, age verification for pornographic websites, and a longer waiting time for teens between getting a learner's permit and a provisional driver's license.

#### Fair Representation

 On December 19 the North Carolina NAACP, Common Cause, and eight black voters filed a suit challenging newly drawn congressional and state legislative maps as racially discriminatory. The lawsuit would not impact districts in the 2024 election, but would potentially force new maps to be drawn for 2026 elections. Republicans in the state legislature responsible for drawing the maps claim that they used partisan data but no racial data in drawing the maps, but advocates say that the maps selectively target Black communities.

On Thursday the Wake County Board of Elections issued a decision in favor of NC Sen. Lisa Grafstein, whose move to her newly redrawn district had been challenged by a Republican opponent. The Board ruled that Grafstein had met the requirement to live in her new district for a year prior to Election Day. While the Board did not address the issue of whether Grafstein is still eligible to serve the remainder of her term in the district she currently serves, Republican leaders of the NCGA have not said they would try to remove her from office.

# **Voting Rights**

- A series of elections law changes went into effect January 1, though multiple groups are suing to stop them. In addition to a new Election Day deadline for receipt of mail-in ballots and increased leeway for partisan poll observers, the new law requires that same-day voter registrants subsequently receive a mailed notice of their registration, with an undeliverable notice causing the registration to be invalidated. The Democratic National Committee, North Carolina Democratic Party, and Voto Latino are among the plaintiffs challenging the law in multiple suits, with two suits specifically challenging the same-day registration provisions. On December 28 a Federal District Court Judge ordered the parties to these two cases to try to reach a compromise, but on Thursday they submitted a court filling stating that they could not do so.
- On Tuesday the State Board of Elections approved a list of 10 counties that will be part of a pilot project to trial a signature-matching test for mail-in ballots. The pilot, which is required by a new law, will use software to test for mismatched signatures on mail-in ballots in Durham, Halifax, Bertie, Wilkes, Montgomery, Rowan, Jones, Pamlico, Henderson, and Cherokee counties. The counties were selected to represent a range of regions, median voting ages, and non-white voting populations.
- On December 19 the North Carolina State Board of Elections voted 4-1 to dismiss a complaint seeking to bar Trump from the ballot based on the 14th Amendment. The complaint was filed by Brian Martin, a retired attorney in Stokes County, on the basis of Trump's actions on January 6, 2021. Republican Speaker of the NC House Tim Moore also told reporters he hoped the NCGA would pass a law prohibiting the Board from disqualifying candidates.

**Education Policy**

- The North Carolina Supreme Court has scheduled a hearing on February 22
   over the Leandro school funding case. Republican leaders in the NCGA are
   challenging a trial judge's right to order that the plan be funded. The previous
   Democratic-majority NC Supreme Court ordered the state to pay for the plan in
   2022.

#### Justice

- On Tuesday NC Supreme Court Chief Justice Paul Newby removed Donna Stroud from her position as Chief Judge of the North Carolina Court of Appeals. Stroud will remain a judge on the court, but the Chief Judge position will be taken by Chris Dillon, a judge with six fewer years of experience on the court. Stroud is a Republican like Newby but has previously drawn criticism from fellow Republican judges, including NC Supreme Court Justice Phil Berger, Jr.
- On December 20 Governor Cooper announced pardons of four people who served felony convictions and have since gone on to productive careers.
   Cooper also commuted the sentence of a 35-year-old man who had been in prison since he was convicted of a felony at the age of 16, following the recommendation of North Carolina's Juvenile Sentence Review Board. Activists participating in a recent monthlong vigil outside the Governor's mansion had identified over 10,000 people as candidates for clemency, and a wideranging coalition has called for a commutation of the sentences of the 136 people on death row.

News from NC Congressman Jeff Jackson, January 12, 2024

Revolt (again) Also, new Speaker = old Speaker

You haven't heard from me for a few weeks because we were all sent home for the holidays, but now we're back. And we immediately hit a brick wall.

The big question is the budget. We were supposed to pass one last year, but we didn't. Instead, we narrowly avoided two government shutdowns by passing two temporary extensions. The first time we did it, the right-flank revolted and fired the Speaker. The second time, it was with the new Speaker. The right-flank didn't fire him, but they grumbled a lot. So, the Speaker promised not to do any more extensions. The next government shutdown is scheduled for one week from today - and we still don't have a budget.

BUT - just before we all came back to D.C. - the Speaker agreed to some major budget terms with the Senate. Most importantly, he agreed on the big budget number, or how much we're gonna spend. The right-flank was furious. They thought the number was too

high. So, they waited until we were all called to the House floor for our first procedural vote of the week. This is the vote that lays out the other votes we're going to take, and it's extremely rare that it fails. Decades can pass without this vote failing.

But the right-flank wanted to send a message, so as soon as the vote began, they started voting against it. Then I watched the Speaker march over to one of the leaders of the right-flank. They were about 30 feet away from me and the Speaker was trying to get this guy to call off the attack and save the vote.

We get five minutes for most votes. There's a big timer on the wall so we can all see how much time we have left. However, once the clock hits zero, the person presiding over the chamber - who is always an ally of the Speaker, because the Speaker picks them - can simply stand there and keep the vote open. Simply put, if they don't go bang with the gavel, the vote technically stays open.

And that's what was happening. I watched as the Speaker tried to coax the rebel leader to stand down and allow the vote to pass while the presiding member looked down from the podium and held the vote open.

It became pretty animated. The rebel leader waved his arms around a bunch. After about five minutes, the Speaker gave up, walked off the floor, the vote officially failed, and we all filed out and waited to hear what the heck was going to happen next.

The next day was one giant pressure campaign from the right-flank against the Speaker. They were in and out of his office, telling the press they might fire him, all kinds of stuff. At one point, one of them even told the press that the Speaker had decided to renege on his deal with the Senate on the budget - which forced the Speaker to come out of his office and basically tell the press, "No, I didn't say that."

No matter what happens with the actual terms of the budget, the Speaker is going to have to pass another extension. He's out of time. In order to do that, he's going to need a lot of votes from the minority party because so many members of the majority party will vote no. At that point, he'll be 1) passing an extension he said he wouldn't pass, and 2) relying on the minority party to get it done.

All of this is basically certain to happen - unless he would rather allow the government to shut down, which he very much does not want.

So, it's just a lot of pain for this guy in the short-term. His right-flank is going to go completely ballistic and we'll see if they actually try and fire him.

### New Speaker = Old Speaker

It should be noted that, at this point, the new Speaker is acting the exact same way as the old Speaker. No daylight that I can see between these two guys. The new Speaker talked tough in order to get the job, but upon getting it promptly saw that he's got one of the smallest majorities in the history of the House of Representatives and that imposes certain mathematical realities on what can and cannot pass. Which is to say, he went from campaign mode to governance mode, and sure enough, that's been a painful transition.
