### **Keep Track of NC Election Turnout Statistics**

Want to track NC election turnout statistics? Check out this Vote Tracker dashboard developed by Civitas/The John Locke Foundation.

Vote Tracker helps people better understand early “one stop” and absentee-by-mail turnout numbers. The data comes straight from the North Carolina Board of Elections, where it is refreshed each morning during the early voting period with the previous day’s data. Vote Tracker’s data filter allows you to examine turnout in individual counties or districts and take a closer look at turnout for parts of the electorate with searches based on age, sex, party registration or several other factors.

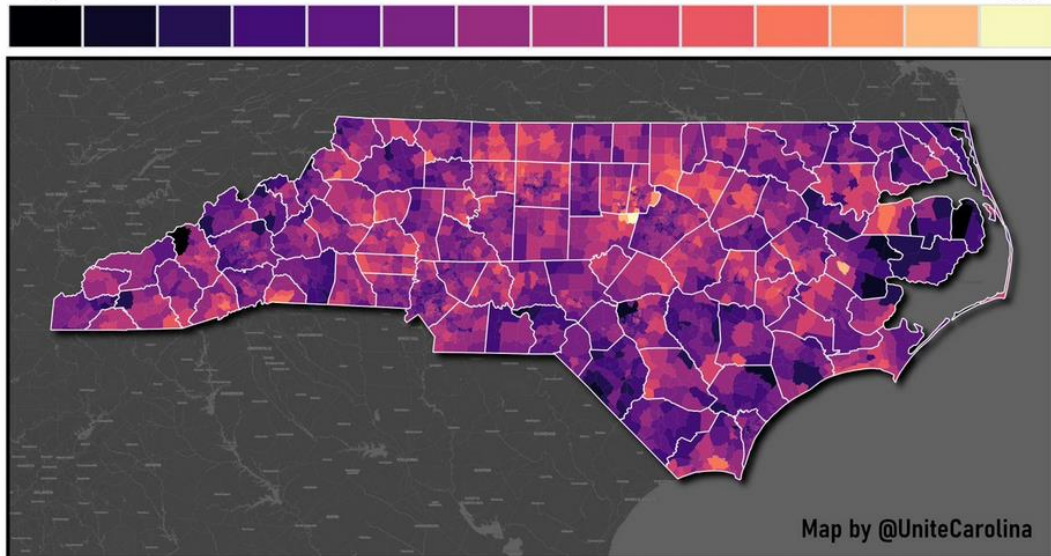

### **2024 General Election Early Voting Poll Greeting (Multiple Dates)**

Poll greeting is one of the most important activities volunteers do. We greet voters at the polls, offer them the Sample Democratic Ballot, encourage them to vote for the candidates on BOTH SIDES of the ballot, and thank them for voting. We also provide a friendly face for folks who may not be entirely comfortable or who may be unsure about the process of voting in person.

### **Be a Poll Observer**

Interested in being a poll observer on Election Day? This year more than ever CCDP Poll Observers watch for any missteps in the election processes inside each polling place. They've been in use for at least a hundred years as a way to promote election

integrity, with the idea that if both parties are watching, it's much harder for either to tamper with the votes. If something goes amiss, poll observers contact a central incident reporting operation.

Poll observers are approved by the Chatham County Board of Elections before they are allowed to be an observer. The Board of Elections requires us to submit name, address, and telephone number, and therefore we must collect that information here.

Names must be submitted to the Board of Elections in advance so sign up will end on Oct 31st. Please sign up for as many shifts as you can before that date.

You must be a registered voter of Chatham County to be a poll observer in Chatham County.

### **Early Voting Began in North Carolina Last Thursday!**

- Early voting began on Thursday (October 17th) in North Carolina!
- Important reminder for folks in your communities: **if they haven't registered to vote yet, they can still register in person!**
- **This past Sunday, Vice President Kamala Harris made her 19th trip to the Tar Heel State** where she rallied over 7,000 North Carolinians in Greenville
- When it comes to early voting sites, **the 25 western counties most impacted by Helene had planned for 80 early voting sites. Seventy-five of them will be operational** when early voting begins.

### **New voter ID rules**

- Due to Republicans in our legislature, this is the first presidential election where residents of our state will be required to present identification when they show up to vote. Acceptable forms of ID include a driver's license, passport and student photo IDs that have been approved by the state election board.
- There are exceptions if a voter is unable to provide identification and one of those exceptions is a natural disaster. In that case, voters fill out an ID exception form that accompanies their ballot. The state election board notes that county election boards are required to count provisional ballots that include ID exception forms.

### **No more grace period for mail ballots**

- Voters considering casting a ballot by mail should note that, **unlike 2020, their ballots need to be received by 7:30 p.m. ET on Election Day.**
- During the last presidential race, there was a three-day grace period for ballots to arrive, which has since been eliminated due to our Republican-led legislature.

He recognizes the education, healthcare, and justice challenges our communities face and the pivotal role played by the courts in ensuring just outcomes.

Before her appointment to the appellate bench, she served as a District Court Judge, Superior Court Judge, and Deputy Commissioner for the Industrial Commission, accounting for over 26 years of combined legal and judicial experience. During her career as an attorney, she successfully maintained a family law practice for 13 years while simultaneously representing the Department of Social Services in prosecuting petitions of abuse, neglect, and nonsupport of children. Her practice always included representing victims of domestic violence and their children.

Judge Thompson has been active in her community as a volunteer Teen Court Judge and a youth mentor for over ten years to help first-time youth offenders accept responsibility for their conduct while learning about the court system. She is also an ordained minister, where she provides domestic violence awareness workshops for the faith community.

Her judicial philosophy is to interpret the law and apply the same to the facts of each case without bias or influenced agendas. For Judge Thompson, true justice is independent of divisive ideologies and social differences. As a public servant, she is a firm believer in the idea that "to whom much is given, much is required." She is mindful that she stands on the shoulders of generations who paved the way for her academic and legal career and is committed to honoring their sacrifices through service to others.

Judge Thompson and her husband have a blended family of five adult children and six grandchildren. She is also a dog mom to Bo, Zeus and Ollie.
